This section will describe in how to copy a Dynamics CRM invoice.

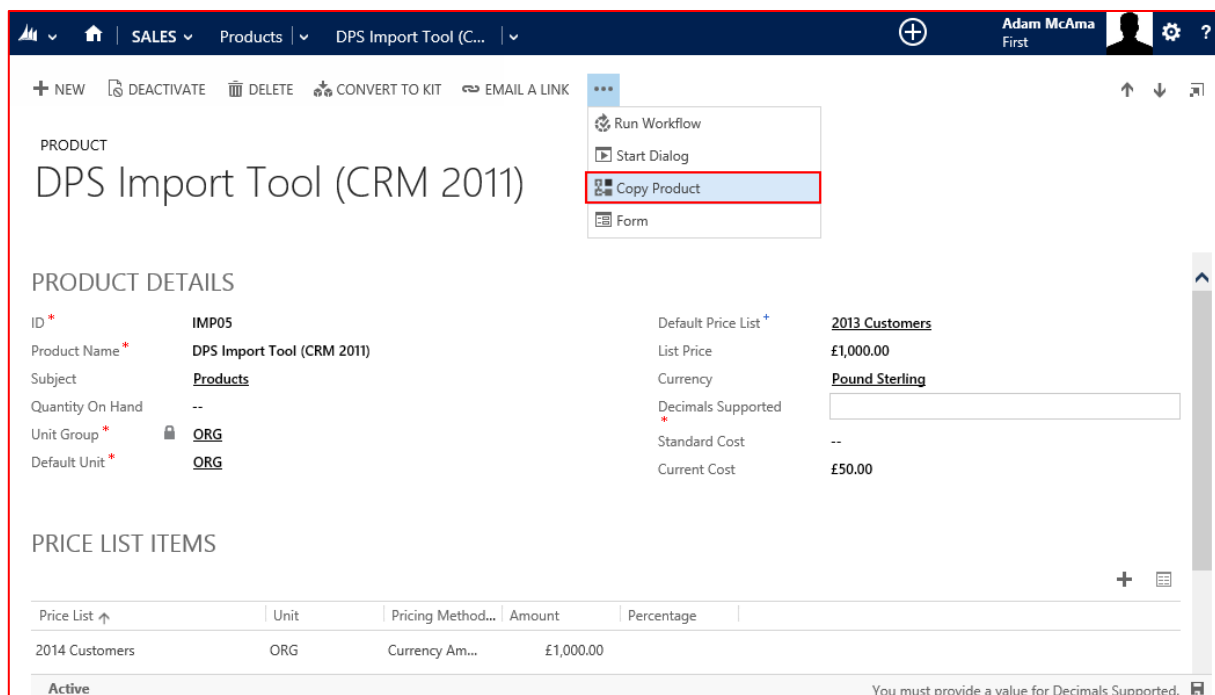
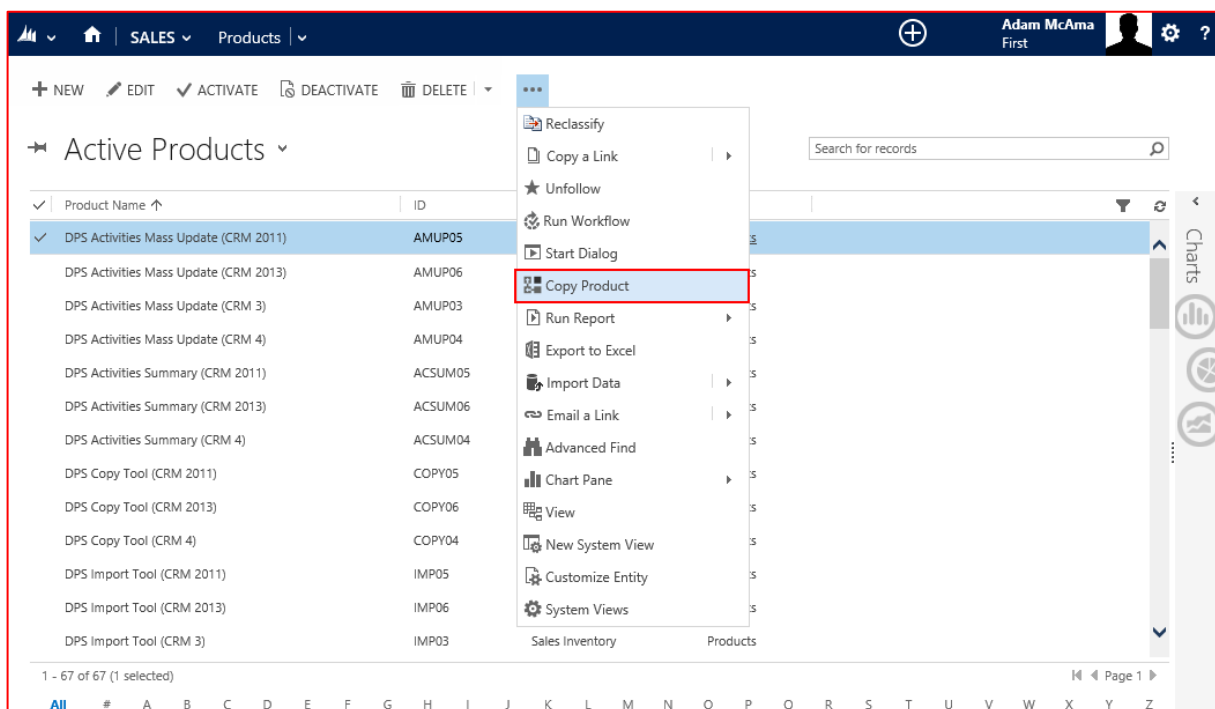
# Functionality

This document will give you step by step instructions how you use Copy Tool.

## Chapter 1: Use Copy Tool to duplicate Products

Follow below steps to duplicate a Product:

1. Log in to Microsoft Dynamics CRM 2013
2. Open Dynamics CRM and select product you wish to copy. Copy Tool can also be used from a record level.



3. Select Copy Product command from Command Bar.
4. “Copy Product” screen will open. Provide new Product ID and select what information from source record should be copied to a new one. Kit Products option will only be available if your source product is a Kit.

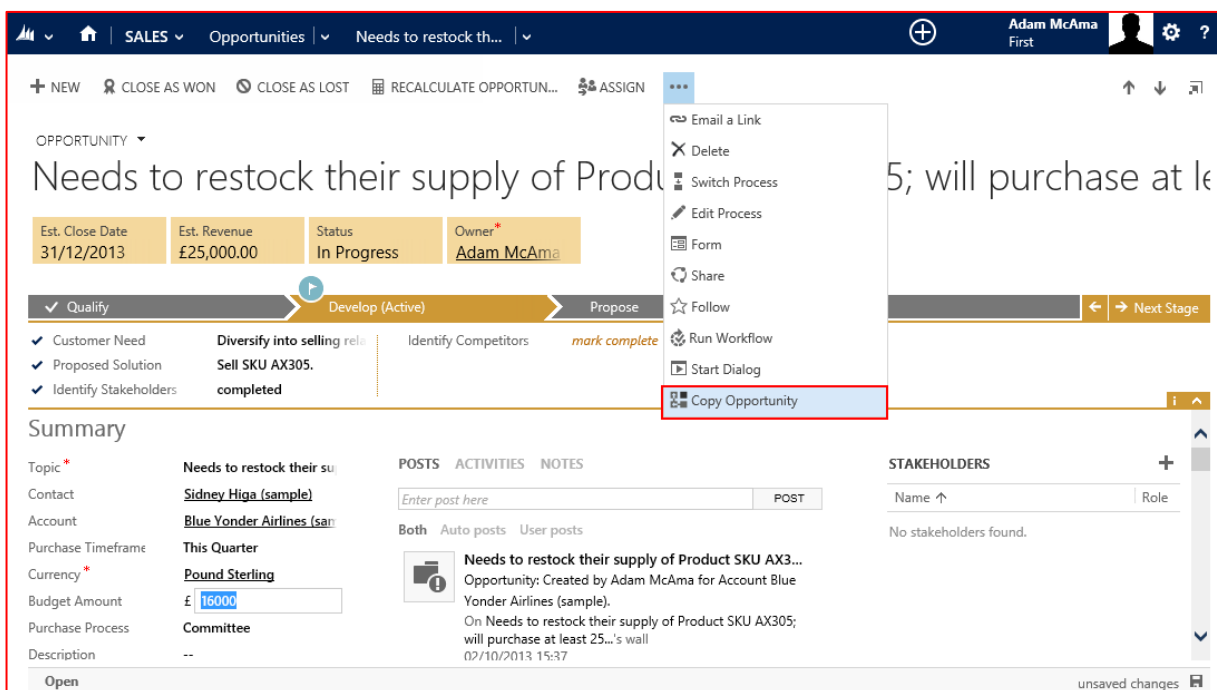
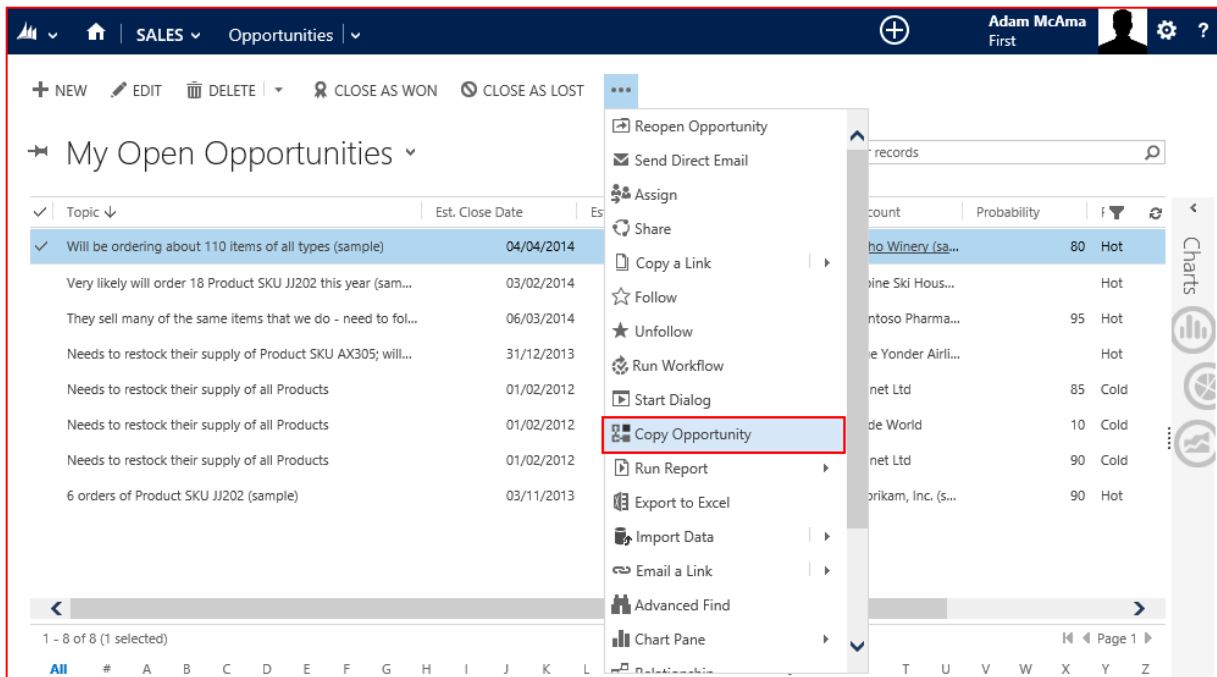

3. “Copy Opportunity” screen will open. Enter value in the Potential Customer field, amend opportunity Topic if required and select what information from source record should be copied to a new one.
